Approval of Minutes from the Previous Meeting

The District Agent stated that the flow meter will need to be replaced and will research the pricing for a new meter.

A. <u>Treasurer's Report</u>

The Board accepted the Treasurer's Report as presented for September 2023 totaling - \$1,012,513.78

B. Bills/Charges and Transfers

The Board reviewed the Bills and Charges totaling **\$12,795.08**. On a motion of Director Swartfager and seconded by Director Noack. The bills and charges were unanimously approved.

C. Appointment of Directors

Directors Arcidiacono, Dangler, and Noack were sworn in for their 4-year terms of office as Directors of the McKinney Water District.

D. Resolution 2023-4 to Transfer Funds to BMO Savings Account

The Resolution attached (Addendum B) will allow the Secretary/Treasurer to transfer funds from the BMO checking account to the Savings Account and close the Checking Account.

On a motion by Director Swartfager seconded by Director Dangler Resolution 2023-4 was unanimously approved

E. El Dorado County Erosion Control Project

A representative from El Dorado County, TCPUD and our District Agent met on October 25th to locate the main lines within the easement between Miami Ave., Hilo Ave and the Conservancy lot at the end of Hilo. El Dorado County reached out to the district in hopes of working together to solve the runoff in these areas. A culvert or other form of erosion control will be discussed. The County will get a variance to put in a culvert (See Addendum C for drawing)

F. Water Sample and District Agent Report – October 2023

The Secy./Treas. presented the District Agent's Monthly Report. The meter is not tracking water production currently. Static 24.8, Dynamic 86.6. Static low for the month 22.5

Coliform/Fecal testing per the sample site plan came back negative. Samples were taken at 590 McKinney Rubicon Springs. in McKinney Estates.
